

The relative strengths and weaknesses of SOUTH PLAINS FINANCIAL INC. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of SOUTH PLAINS FINANCIAL INC. compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 39% points. The greatest weakness of SOUTH PLAINS FINANCIAL INC. is the variable Loans and Leases Receivable, reducing the Economic Capital Ratio by 24% points.

The company's Economic Capital Ratio, given in the ranking table, is 7.3%, being 0.72% points above the market average of 6.6%.
