

The relative strengths and weaknesses of USCB FINANCIAL HOLDINGS INC. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of USCB FINANCIAL HOLDINGS INC. compared to the market average is the variable Liabilities and Borrowings, increasing the Economic Capital Ratio by 14% points. The greatest weakness of USCB FINANCIAL HOLDINGS INC. is the variable Other Liabilities, reducing the Economic Capital Ratio by 15% points.

The company's Economic Capital Ratio, given in the ranking table, is 6.6%, being 0.065% points above the market average of 6.5%.
