

Meravis Wohnungsbauund Immobilien

The relative strengths and weaknesses of Meravis Wohnungsbau und Immobilien GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Meravis Wohnungsbau und Immobilien GmbH Konzern compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 66% points. The greatest weakness of Meravis Wohnungsbau und Immobilien GmbH Konzern is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 284% points.

The company's Economic Capital Ratio, given in the ranking table, is 66%, being 35% points below the market average of 101%.
