

The relative strengths and weaknesses of Bickhardt Bau Aktiengesellschaft Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bickhardt Bau Aktiengesellschaft Konzern compared to the market average is the variable Bs Ass Currass Inventory Inprogress Rem, increasing the Economic Capital Ratio by 98% points. The greatest weakness of Bickhardt Bau Aktiengesellschaft Konzern is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 522% points.

The company's Economic Capital Ratio, given in the ranking table, is 98%, being 0,84% points below the market average of 99%.
