The greatest strength of Freiburger Stadtbau Gesellschaft mit Beschränkter Haftung FSB compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 79% points. The greatest weakness of Freiburger Stadtbau Gesellschaft mit Beschränkter Haftung FSB is the variable Operating Result Tc, reducing the Economic Capital Ratio by 281% points.

The company's Economic Capital Ratio, given in the ranking table, is 79%, being 18% points below the market average of 96%.
