

#### Bateg GmbH Rank 49 of 116

The relative strengths and weaknesses of Bateg GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bateg GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 98% points. The greatest weakness of Bateg GmbH is the variable Bs Ass Currass Inventory Inprogress Services Rem, reducing the Economic Capital Ratio by 770% points.

The company's Economic Capital Ratio, given in the ranking table, is 98%, being 5,4% points below the market average of 103%.
