

Arning Bauunternehmung GmbH Rank 51 of 116

The relative strengths and weaknesses of Arning Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Arning Bauunternehmung GmbH compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 88% points. The greatest weakness of Arning Bauunternehmung GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 174% points.

The company's Economic Capital Ratio, given in the ranking table, is 95%, being 8,2% points below the market average of 103%.
