

Rensch Haus GmbH Rank 30 of 116

The relative strengths and weaknesses of Rensch Haus GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Rensch Haus GmbH compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 114% points. The greatest weakness of Rensch Haus GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 638% points.

The company's Economic Capital Ratio, given in the ranking table, is 114%, being 11% points above the market average of 103%.
