

The relative strengths and weaknesses of HBB Hanseatische Wohnungsbaugesellschaft mbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HBB Hanseatische Wohnungsbaugesellschaft mbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 145% points. The greatest weakness of HBB Hanseatische Wohnungsbaugesellschaft mbH Co KG is the variable Cost Of Purchased Services Tc, reducing the Economic Capital Ratio by 374% points.

The company's Economic Capital Ratio, given in the ranking table, is 145%, being 43% points above the market average of 103%.
