

The greatest strength of Otto Wulff Bauunternehmung GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 158% points. The greatest weakness of Otto Wulff Bauunternehmung GmbH is the variable Bs Ass Currass Inventory Inprogress Rem, reducing the Economic Capital Ratio by 958% points.

The company's Economic Capital Ratio, given in the ranking table, is 158%, being 51% points above the market average of 106%.






