

The relative strengths and weaknesses of Kruppa Bauunternehmen GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Kruppa Bauunternehmen GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Rem, increasing the Economic Capital Ratio by 69% points. The greatest weakness of Kruppa Bauunternehmen GmbH Co KG is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, reducing the Economic Capital Ratio by 165% points.

The company's Economic Capital Ratio, given in the ranking table, is 82%, being 24% points below the market average of 106%.
