

The relative strengths and weaknesses of Markgraf Familien GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Markgraf Familien GmbH Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 96% points. The greatest weakness of Markgraf Familien GmbH Konzern is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 505% points.

The company's Economic Capital Ratio, given in the ranking table, is 96%, being 10,0% points below the market average of 106%.
