

### THB Tief und Hausbau GmbH Rank 8 of 113

The relative strengths and weaknesses of THB Tief und Hausbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of THB Tief und Hausbau GmbH compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 172% points. The greatest weakness of THB Tief und Hausbau GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 607% points.

The company's Economic Capital Ratio, given in the ranking table, is 172%, being 69% points above the market average of 103%.
