

The greatest strength of Wolf System GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 162% points. The greatest weakness of Wolf System GmbH is the variable Is Netincome Regular Operatingtc Rem, reducing the Economic Capital Ratio by 1.466% points.


The company's Economic Capital Ratio, given in the ranking table, is 162%, being 59% points above the market average of 103%.
