

Stuckert Wohnbau

The relative strengths and weaknesses of Stuckert Wohnbau Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Stuckert Wohnbau Aktiengesellschaft compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Propertysales Rem, increasing the Economic Capital Ratio by 129% points. The greatest weakness of Stuckert Wohnbau Aktiengesellschaft is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Rem, reducing the Economic Capital Ratio by 288% points.

The company's Economic Capital Ratio, given in the ranking table, is 131%, being 27% points above the market average of 103%.
