



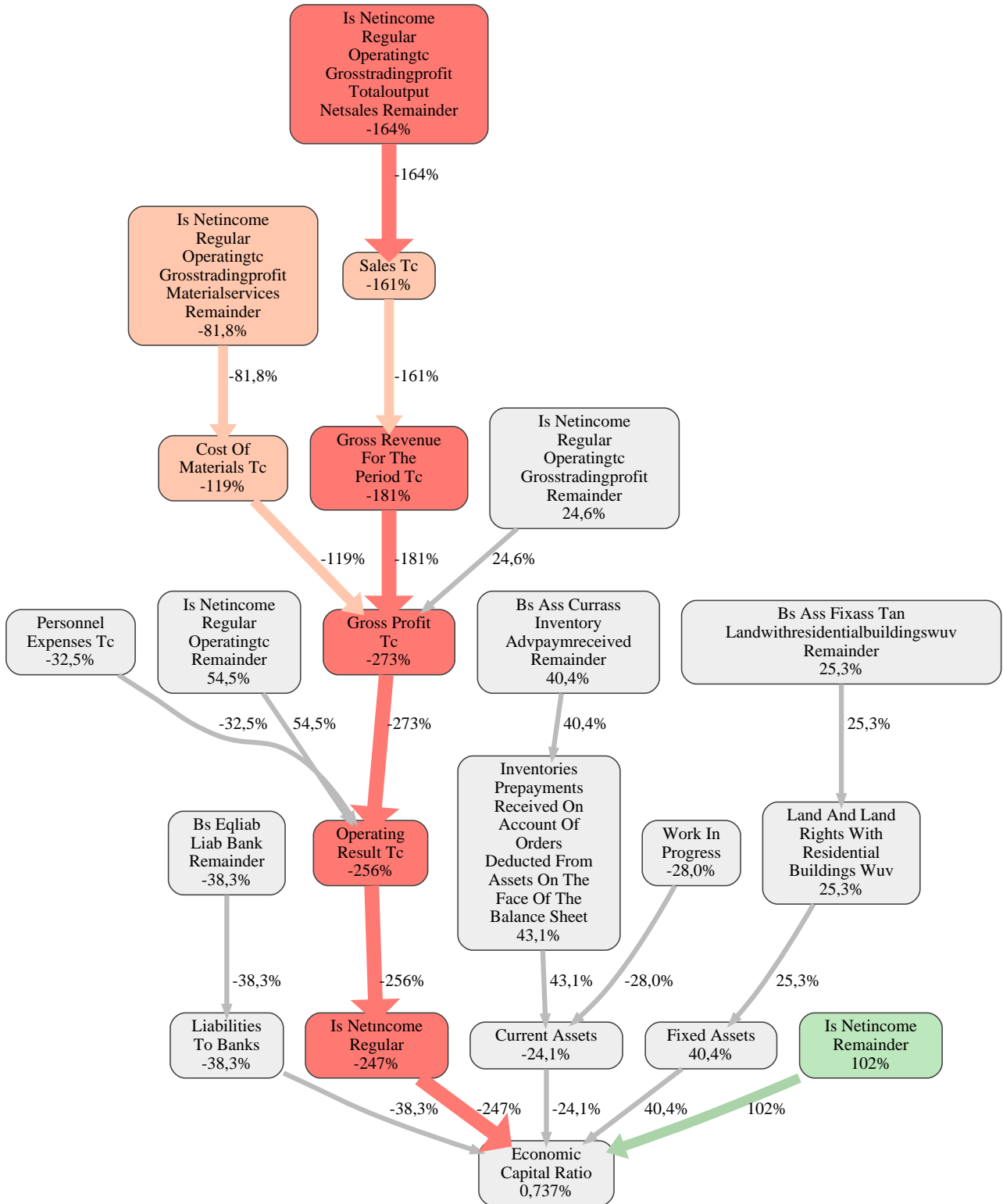

The greatest strength of WBM Wohnungsbaugesellschaft Berlin Mitte mit Beschränkter Haftung compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 102% points. The greatest weakness of WBM Wohnungsbaugesellschaft Berlin Mitte mit Beschränkter Haftung is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 273% points.

The company's Economic Capital Ratio, given in the ranking table, is 102%, being 0,74% points above the market average of 102%.
