

Hanova Wohnen GmbH Rank 92 of 110

The relative strengths and weaknesses of Hanova Wohnen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hanova Wohnen GmbH compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 61% points. The greatest weakness of Hanova Wohnen GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 469% points.

The company's Economic Capital Ratio, given in the ranking table, is 61%, being 141% points below the market average of 202%.
