





The relative strengths and weaknesses of Gewobag Wohnungsbau Aktiengesellschaft Berlin Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gewobag Wohnungsbau Aktiengesellschaft Berlin Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 38% points. The greatest weakness of Gewobag Wohnungsbau Aktiengesellschaft Berlin Konzern is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 256% points.

The company's Economic Capital Ratio, given in the ranking table, is 38%, being 65% points below the market average of 103%.
