

Swietelsky Baugesellschaft m b H Rank 5 of 9

The relative strengths and weaknesses of Swietelsky Baugesellschaft m b H are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Swietelsky Baugesellschaft m b H compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 68% points. The greatest weakness of Swietelsky Baugesellschaft m b H is the variable Bs Ass Currass Inventory Inprogress Constructioninprogress Rem, reducing the Economic Capital Ratio by 108.875% points.

The company's Economic Capital Ratio, given in the ranking table, is 68%, being 26% points below the market average of 94%.
