

### DR Seifert Wilmersdorfer Hochbau Aktiengesellschaft Rank 42 of 107

The relative strengths and weaknesses of DR Seifert Wilmersdorfer Hochbau Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of DR Seifert Wilmersdorfer Hochbau Aktiengesellschaft compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 94% points. The greatest weakness of DR Seifert Wilmersdorfer Hochbau Aktiengesellschaft is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 278% points.

The company's Economic Capital Ratio, given in the ranking table, is 97%, being 4,4% points below the market average of 101%.
