

The relative strengths and weaknesses of Gunter Hüttner Co GmbH Bauunternehmung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gunter Hüttner Co GmbH Bauunternehmung compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, increasing the Economic Capital Ratio by 85% points. The greatest weakness of Gunter Hüttner Co GmbH Bauunternehmung is the variable Gross Revenue For The Period Tc, reducing the Economic Capital Ratio by 217% points.

The company's Economic Capital Ratio, given in the ranking table, is 85%, being 16% points below the market average of 101%.
