

SEH Engineering GmbH Rank 54 of 107

The relative strengths and weaknesses of SEH Engineering GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of SEH Engineering GmbH compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 91% points. The greatest weakness of SEH Engineering GmbH is the variable Bs Ass Currass Inventory Inprogress Goods Rem, reducing the Economic Capital Ratio by 4.398% points.

The company's Economic Capital Ratio, given in the ranking table, is 91%, being 10% points below the market average of 101%.
