

The greatest weakness of Joachim Nesseler Geschäftsführungsgesellschaft mbh Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, reducing the Economic Capital Ratio by 384% points.

The company's Economic Capital Ratio, given in the ranking table, is 161%, being 60% points above the market average of 101%.
