The greatest strength of B O Bau und Projekte GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Services Rem, increasing the Economic Capital Ratio by 143% points. The greatest weakness of B O Bau und Projekte GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, reducing the Economic Capital Ratio by 811% points.

The company's Economic Capital Ratio, given in the ranking table, is 143%, being 44% points above the market average of 99%.


