

The relative strengths and weaknesses of Wadle Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wadle Bauunternehmung GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 140% points. The greatest weakness of Wadle Bauunternehmung GmbH is the variable Bs Ass Currass Inventory Inprogress Constructioninprogress Rem, reducing the Economic Capital Ratio by 2.540% points.

The company's Economic Capital Ratio, given in the ranking table, is 140%, being 42% points above the market average of 99%.
