

The greatest strength of B O Wohnungswirtschaft GmbH Chemnitz Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Services Rem, increasing the Economic Capital Ratio by 129% points. The greatest weakness of B O Wohnungswirtschaft GmbH Chemnitz Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, reducing the Economic Capital Ratio by 914% points.

The company's Economic Capital Ratio, given in the ranking table, is 129%, being 30% points above the market average of 99%.
