

Kögel Bau GmbH Co KG Rank 66 of 115

The relative strengths and weaknesses of Kögel Bau GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Kögel Bau GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, increasing the Economic Capital Ratio by 80% points. The greatest weakness of Kögel Bau GmbH Co KG is the variable Bs Ass Currass Inventory Rem, reducing the Economic Capital Ratio by 622% points.

The company's Economic Capital Ratio, given in the ranking table, is 80%, being 16% points below the market average of 97%.
