

The relative strengths and weaknesses of Mayerhofer Hoch Tief und Ingenieurbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Mayerhofer Hoch Tief und Ingenieurbau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 100% points. The greatest weakness of Mayerhofer Hoch Tief und Ingenieurbau GmbH is the variable Finished Goods And Merchandise, reducing the Economic Capital Ratio by 451% points.

The company's Economic Capital Ratio, given in the ranking table, is 100%, being 3,6% points above the market average of 97%.
