

BCS Planungsund Hausvertriebs

The relative strengths and weaknesses of BCS Planungs und Hausvertriebs GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BCS Planungs und Hausvertriebs GmbH compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 32% points. The greatest weakness of BCS Planungs und Hausvertriebs GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 313% points.

The company's Economic Capital Ratio, given in the ranking table, is 32%, being 65% points below the market average of 97%.
