

#### Moser GmbH Co KG Rank 61 of 115

The relative strengths and weaknesses of Moser GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Moser GmbH Co KG compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 85% points. The greatest weakness of Moser GmbH Co KG is the variable Work In Progress, reducing the Economic Capital Ratio by 18.328% points.

The company's Economic Capital Ratio, given in the ranking table, is 85%, being 12% points below the market average of 97%.
