

The relative strengths and weaknesses of Krüger Hochbau GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Krüger Hochbau GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, increasing the Economic Capital Ratio by 80% points. The greatest weakness of Krüger Hochbau GmbH Co KG is the variable Gross Revenue For The Period Tc, reducing the Economic Capital Ratio by 350% points.

The company's Economic Capital Ratio, given in the ranking table, is 80%, being 23% points below the market average of 103%.
