

The greatest strength of Hans Graf Bauunternehmung GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Staff Rem, increasing the Economic Capital Ratio by 113% points. The greatest weakness of Hans Graf Bauunternehmung GmbH Co KG is the variable Is Netincome Regular Operatingtc Rem, reducing the Economic Capital Ratio by 392% points.

The company's Economic Capital Ratio, given in the ranking table, is 113%, being 9,8% points above the market average of 103%.
