

#### Bien Zenker GmbH Rank 94 of 116

The relative strengths and weaknesses of Bien Zenker GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bien Zenker GmbH compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 66% points. The greatest weakness of Bien Zenker GmbH is the variable Is Netincome Regular Operatingtc Rem, reducing the Economic Capital Ratio by 724% points.

The company's Economic Capital Ratio, given in the ranking table, is 66%, being 37% points below the market average of 103%.
