

The greatest strength of Bickhardt Bau Aktiengesellschaft Konzern compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 91% points. The greatest weakness of Bickhardt Bau Aktiengesellschaft Konzern is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 348% points.

The company's Economic Capital Ratio, given in the ranking table, is 91%, being 12% points below the market average of 103%.
