

#### Haas Fertigbau GmbH Rank 41 of 116

The relative strengths and weaknesses of Haas Fertigbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Haas Fertigbau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 114% points. The greatest weakness of Haas Fertigbau GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 686% points.

The company's Economic Capital Ratio, given in the ranking table, is 114%, being 8,0% points above the market average of 106%.
