

SVI Vertriebsund Immobilien

The relative strengths and weaknesses of SVI Vertriebs und Immobilien GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of SVI Vertriebs und Immobilien GmbH compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 140% points. The greatest weakness of SVI Vertriebs und Immobilien GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 418% points.

The company's Economic Capital Ratio, given in the ranking table, is 141%, being 35% points above the market average of 106%.
