

Dreßler Bau

The relative strengths and weaknesses of Dreßler Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Dreßler Bau GmbH compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 141% points. The greatest weakness of Dreßler Bau GmbH is the variable Bs Ass Currass Inventory Inprogress Construction in progress Rem, reducing the Economic Capital Ratio by 568% points.

The company's Economic Capital Ratio, given in the ranking table, is 141%, being 38% points above the market average of 103%.


