

SEH Engineering GmbH Rank 95 of 113

The relative strengths and weaknesses of SEH Engineering GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of SEH Engineering GmbH compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 58% points. The greatest weakness of SEH Engineering GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 275% points.

The company's Economic Capital Ratio, given in the ranking table, is 58%, being 46% points below the market average of 103%.
