The greatest weakness of Joachim Nesseler Geschäftsführungsgesellschaft mbh Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, reducing the Economic Capital Ratio by 372% points.

The company's Economic Capital Ratio, given in the ranking table, is 86%, being 17% points below the market average of 103%.
