The greatest weakness of Otto Wulff Bauunternehmung GmbH Konzern is the variable Cost Of Purchased Services Tc, reducing the Economic Capital Ratio by 142% points.

The company's Economic Capital Ratio, given in the ranking table, is 105%, being 1,8% points above the market average of 103%.
