

BMS Industriebau GmbH Rank 73 of 110

The relative strengths and weaknesses of BMS Industriebau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BMS Industriebau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Rem, increasing the Economic Capital Ratio by 76% points. The greatest weakness of BMS Industriebau GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 576% points.

The company's Economic Capital Ratio, given in the ranking table, is 76%, being 126% points below the market average of 202%.
