

The greatest strength of Wunstorfer Bauverein Wohnungsbau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Staff Salaries Rem, increasing the Economic Capital Ratio by 0,099% points. The greatest weakness of Wunstorfer Bauverein Wohnungsbau GmbH is the variable Net Income, reducing the Economic Capital Ratio by 295% points.

The company's Economic Capital Ratio, given in the ranking table, is 0,099%, being 202% points below the market average of 202%.
