

#### VSTR AG Rodewisch Konzern Rank 49 of 110

The relative strengths and weaknesses of VSTR AG Rodewisch Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of VSTR AG Rodewisch Konzern compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 101% points. The greatest weakness of VSTR AG Rodewisch Konzern is the variable Operating Result Tc, reducing the Economic Capital Ratio by 519% points.

The company's Economic Capital Ratio, given in the ranking table, is 101%, being 101% points below the market average of 202%.
