

Ortwin Goldbeck Holding SE Rank 7 of 9

The relative strengths and weaknesses of Ortwin Goldbeck Holding SE are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Ortwin Goldbeck Holding SE compared to the market average is the variable Is Netincome Regular Operatingtc Rem, increasing the Economic Capital Ratio by 63% points. The greatest weakness of Ortwin Goldbeck Holding SE is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 357% points.

The company's Economic Capital Ratio, given in the ranking table, is 63%, being 32% points below the market average of 94%.
