



The relative strengths and weaknesses of Himmel u Papesch Bauunternehmung GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Himmel u Papesch Bauunternehmung GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, increasing the Economic Capital Ratio by 71% points. The greatest weakness of Himmel u Papesch Bauunternehmung GmbH Co KG is the variable Bs Ass Currass Inventory Rem, reducing the Economic Capital Ratio by 708% points.

The company's Economic Capital Ratio, given in the ranking table, is 71%, being 30% points below the market average of 101%.
