



The relative strengths and weaknesses of Fritz Meyer GmbH Bauunternehmung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Fritz Meyer GmbH Bauunternehmung compared to the market average is the variable Gross Revenue For The Period Tc, increasing the Economic Capital Ratio by 171% points. The greatest weakness of Fritz Meyer GmbH Bauunternehmung is the variable Work In Progress, reducing the Economic Capital Ratio by 11.964% points.

The company's Economic Capital Ratio, given in the ranking table, is 171%, being 70% points above the market average of 101%.
