



The relative strengths and weaknesses of Kruppa Bauunternehmen GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Kruppa Bauunternehmen GmbH Co KG compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 56% points. The greatest weakness of Kruppa Bauunternehmen GmbH Co KG is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 298% points.

The company's Economic Capital Ratio, given in the ranking table, is 57%, being 45% points below the market average of 101%.
