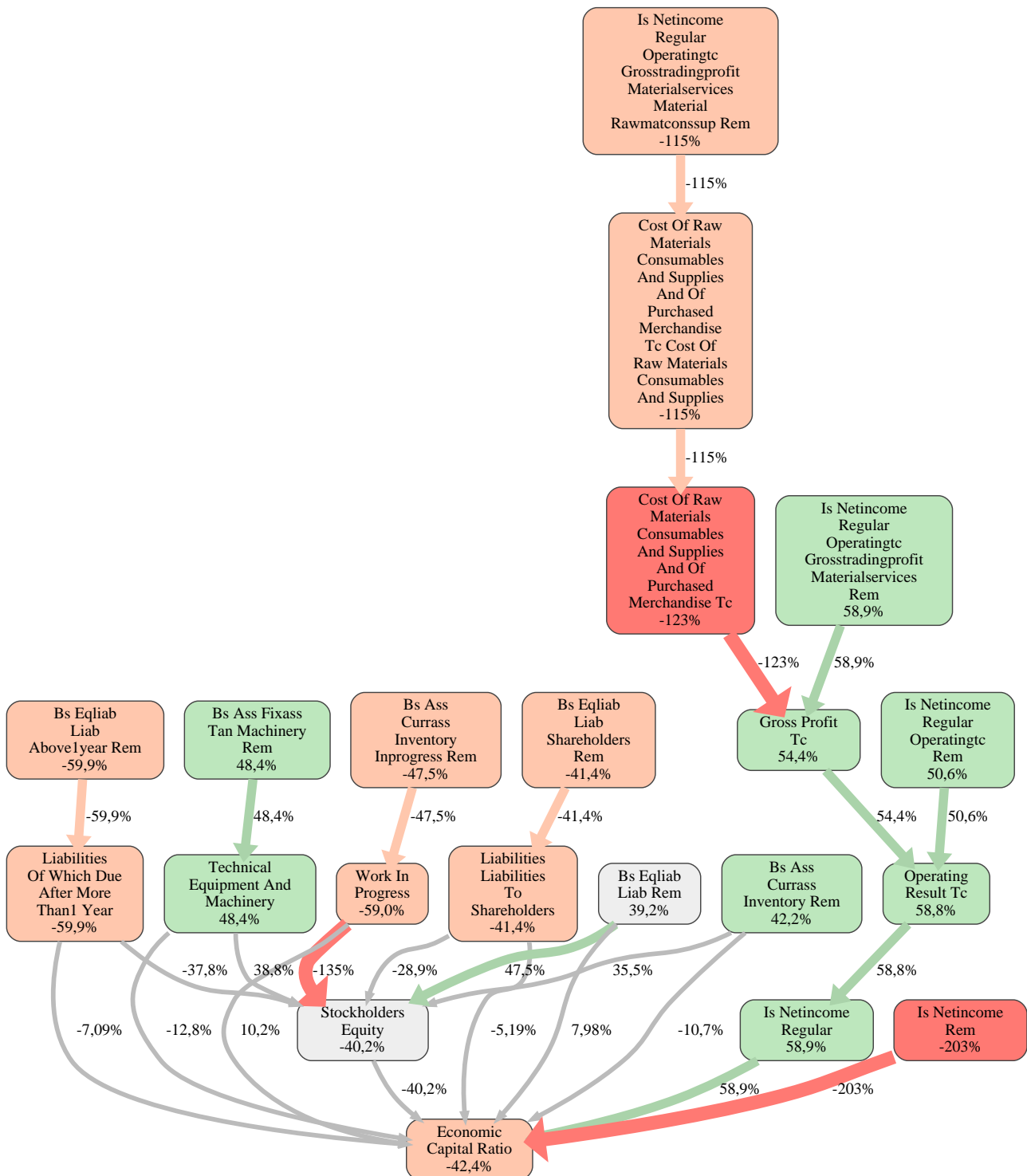

The greatest strength of Hanova Services GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 59% points. The greatest weakness of Hanova Services GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 203% points.

The company's Economic Capital Ratio, given in the ranking table, is 59%, being 42% points below the market average of 101%.
