



The relative strengths and weaknesses of Wunstorfer Bauverein Wohnungsbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wunstorfer Bauverein Wohnungsbau GmbH compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 141% points. The greatest weakness of Wunstorfer Bauverein Wohnungsbau GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 324% points.

The company's Economic Capital Ratio, given in the ranking table, is 142%, being 41% points above the market average of 101%.
