



The relative strengths and weaknesses of Florack Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Florack Bauunternehmung GmbH compared to the market average is the variable Bs Ass Currass Inventory Rem, increasing the Economic Capital Ratio by 77% points. The greatest weakness of Florack Bauunternehmung GmbH is the variable Gross Revenue For The Period Tc, reducing the Economic Capital Ratio by 231% points.

The company's Economic Capital Ratio, given in the ranking table, is 77%, being 22% points below the market average of 99%.
